**Sibling Discounts** apply to *Tuition Fees only*, at a rate of 20% off for the first sibling, 40% sibling, 60% off for the third sibling and 100% off for the fourth sibling.

**Health Care Card (HCC)** discounts apply where the person who holds the card pays the fee

*A valid HCC must be presented to the school before this discount can be applied*

HCC holders pay \$300 for tuition/amenities, but are charged for third party costs eg swimming

**Amenities:** Amenities, information technology, athletics, copy paper

**Excursions:** Excursions, incursions, swimming, Edudance and sporting activities.

**Building and P & F Levies:** are family charges only. The building levy is reduced for HCC holders

**Other activities:** Insurance cover, sacramental programmes, Yr 6 camp and Yr 6 graduation
